

## **BIG JUMP IN SINGLE-FAMILY STARTS**



Housing starts edged 0.2% higher in July to an annual rate of 1206k, essentially maintaining a large 12.3% gain in June and an annual pace of 1204k. Starts are trending higher and are now up 10.1% from their level in July 2014. Single family starts jumped 12.8% last month to an annual pace of 782k and are now 19% higher than their July 2014 level. Multifamily housing starts declined 17.0% last month and are down 2.1% from July 2014. Regionally, housing starts fell in the Northeast while gaining strongly in the Midwest, West and South. Housing permit issuance, which is often viewed as a proxy for future building plans, fell 16.3% in July to an annual rate of 1119k led by a huge 31.8% decline in multifamily issuance. Single family permit issuance was down a modest 1.9% on the month. The sharp decline in building permits was expected and related to a change in New York City real estate law that pulled multifamily permits into June at the expense of July. Excluding permits in the Northeast, total U.S. permits continue to trend higher and are running ahead of starts, which suggests homebuilding should continue to improve over the next couple of months.
